 - d. to allow glass bottles within the Beer Booth area only. Alcohol will be transferred into non-glass containers before serving for consumption in the park on Sunday, May 2, 2021
 - e. to allow for alcohol purchased in the auction to be in glass containers and the alcohol auction/raffle items to be held in the auction booth until the item is removed from the premises.
 - f. to disallow personal alcohol from being brought on the premises during the day of the bazaar, May 2, 2021;
 - g. to allow persons to be in the park after hours from 9:00 pm Friday, April 30, 2021, until 8:00 a.m. Monday, May 3, 2021, for cooking, maintenance, and cleaning.
 - h. to allow the use of motorized vehicles in the park for set up, maintenance, and clean up from Friday, April 30, 2021 through Monday, May 3, 2021;
 - i. to allow the sale of BBQ pits and fire grills in the pavilion area during the bazaar;

- j. to allow the dumpsters to be placed adjacent to the park for event use; and
- k. to allow BBQ trailers in the park from 8:00 a.m. on Friday, April 30, 2021, through 12:00 noon, Monday, May 3, 2020.

The Catholic Church is aware that they will need security for this event and will discuss the details with the Chief of Police for approval prior to the bazaar on May 2, 2021. A Covid-19 plan to be furnished to the Mayor for approval prior to the event if the City of Danbury is still under a Disaster Declaration.
