CLOSING OF CERTAIN STREETS

REAFFIRMED BY # 36

ORDINANCE NO. 22

AN ORDINANCE EVIDENCING THE INTENT OF THE CITY COUNCIL OF DANBURY, TEXAS, TO CLOSE, VACATE AND ABANDON A PORTION OF A 60' STREET KNOWN AS "AVENUE H" WHICH LIES BETWEEN BLOCKS 128 and 129 IN THE CITY OF DANBURY, ACCORDING TO THE PLAT OF THE TOWN OF DANBURY RECORDED IN VOLUME 80, PAGES 626 AND 627, DEED RECORDS OF BRAZORIA COUNTY, TEXAS, AND MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS IN THE FOLLOWING MANNER, TO-WIT:

BEGINNING at a point on the East corner of Block 128, Town of Danbury, Brazoria County, Texas;
THENCE N 50° 07' W along the Southwest line of Avenue H and the Northeast line of Block 128, 200.49 feet to a point on the North corner of Block 128;
THENCE N 60° 10'21" E along the North line of the Town of Danbury, 63.97 feet to the West corner of Block 129;
THENCE S 50° 07' E along the Southwest line of Block 129 and the Northeast line of said Avenue H, 178.31 feet to the South corner of Block 129;
THENCE S 39° 53' W 60.00 feet to the place of beginning.
The above described portion of Avenue H contains 0.26 acres of land, more or less.

WHEREAS, it has been brought to the attention of the Mayor and the City Council of the town of Danbury, Texas, that the above-described premises in the title of this ordinance lie between two parts of a cemetery established within the town of Danbury and

WHEREAS this portion of the town of Danbury above described has had placed upon it the graves of several people, it is found by the City Council of the town of Danbury and the Mayor of the town of Danbury that it is in the best interest of said town of Danbury that the above-described tract and parcel of land which is now a part of Avenue H within the town of Danbury, be vacated, abandoned, and closed and that same shall revert to the cemetery and be considered hereafter a part of said cemetery.

NOW, THEREFORE :

Section 1. Be it ordained by the City Council and the Mayor of the town of Danbury, Texas, that the following described tract and parcel of land lying and being situated within the town of Danbury as above described, be vacated, abandoned, and closed as a part of the city streets of the town of Danbury and be used hereafter for the sole purpose of a cemetery for the people of the town of Danbury, Texas, said tract and parcel of land being described as follows:

BEGINNING at a point on the East corner of Block 128, Town of Danbury, Brazoria County, Texas;
THENCE N 50° 07' W along the Southwest line of Avenue H and the Northeast line of Block 128, 200.49 feet to a point on the North corner of Block 128;

THENCE N 60° 10' 21" E along the North line of the
Town of Danbury, 63.97 feet to the West corner of Block 129;
THENCE S 50° 07' E along the Southwest line of Block 129
and the Northeast line of said Avenue H, 178.31 feet to the
South corner of Block 129;
THENCE S 39° 53' W 60.00 feet to the place of beginning.
The above described portion of Avenue H contains 0.26 acres
of land, more or less.

Section 2. The fact that the tract of land hereinabove described
is presently being used as a cemetery and will hereafter be used as
a cemetery and the space is badly needed therefor and the Council
of Danbury has expressed a desire therefor, said situation creates
an emergency and imperative public necessity requiring that the
rule which provides that the City Ordinances be read on three and
several days before their passage be and the same is hereby suspended
and this ordinance shall take effect from and after its passage.

PASSED by the City Council of the town of Danbury by a
vote of 5 ayes and 0 nays on this the 28th day of
March, 1966.
