ORDINANCE NO. 87-2

AN ORDINANCE OF THE CITY OF DANBURY, BRAZORIA COUNTY, TEXAS, CHANGING AND AMENDING THE DESIGNATED NAME OF ONE CERTAIN STREET AND ROADWAY CONTAINED WITHIN THE CITY OF DANBURY PROPER, AND AUTHORIZING THE CITY COUNCIL TO TAKE SUCH ACTIONS AS MAY BE REASONABLY APPROPRIATE AND NECESSARY TO EFFECTUATE THE CHANGES OF THE SAID NAME OF STREET AND ROADWAY UPON ANY OFFICIAL DOCUMENTS FILED OF RECORD IN BRAZORIA COUNTY, OR PLATS THEREOF.

WHEREAS, the City Council of the City of Danbury, Brazoria

County, Texas, has been requested to amend and change the street name
of that street heretofore known as First Street as the same extends
between Avenue "A" and Avenue "L" within the boundaries of the City
of Danbury, to Panther Drive, and

WHEREAS, it is the opinion of the City Council of the said City that the said change of name is fitting and proper, and will promote the welfare of the City,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Danbury, Brazoria County, Texas, duly assembled, with a quorum present, as follows, to-wit:

- 1. Hereafter, that portion of First Street, extending between Avenue "A" and Avenue "L" shall hereafter be renamed and denominated as Panther Drive.
- 2. The City Council of Danbury, Texas, shall be entitled and is hereby authorized to take such actions as may be reasonably necessary and legally required to effectuate any changes of plat maps, and the Official Records of Brazoria County, Texas, by filing correction documents if the same shall be required, and the Mayor and City Secretary

shall further be empowered to execute all such documents required as hereinabove set forth.

3. If any section, paragraph, subdivision, clause, phrase or provision of this ordinance shall be adjudicated invalid or unconstitutional, or be unenforceable for any reason, the same shall not affect the validity of this Ordinance as a whole, or any part thereof, other than the part which is invalid, unconstitutional, or unenforceable.
