POOL SAFETY BARRIERS TO BE IN PLACE PRIOR TO FINAL POOL INSPECTION.

- 1) INSTALL A 30 SECOND ALARM ON ALL DOORS THAT OPEN TO POOL YARD. USE A UL 2017 LISTED ALARM.
- 2) FENCE MUST BE A MINIMUM HEIGHT OF 48", CANNOT HAVE GAPS LARGE ENOUGH FOR A SPHERE FOUR INCHES IN DIAMETER TO PASS THROUGH, ALL PERSONNEL GATES TO BE OUTWARD SWINGING, SELF CLOSING/SELF LATCHING AND ALL LATCHES TO BE MIN 60" ABOVE EXTERIOR GRADE FOR NON-POOL SIDE AND MIN OF 3" BELOW TOP OF FENCE ON POOL SIDE.
- 3) SUCTION ENTRAPMENT AVOIDANCE FOR POOLS AND SPAS SHALL BE PROVIDED IN ACCORDANCE WITH APSP 7.
- 4) ALL WINDOWS 60" OR LESS TO WATER'S EDGE REQUIRED TO HAVE SAFETY GLAZING.
- 5) POOL BACKWASH LINE TO BE CONNECTED TO THE SANITARY SEWER THROUGH A P-TRAP.
- 6) POOL MUST BE LOCATED A MINIMUM OF 5' FROM SEPTIC TANKS AND 25' FROM THE OUTER EDGE OF THE SEPTIC SPRAY ZONE.
- 7) IF POOL IS HEATED, AN ON-OFF SWITCH SHALL BE INSTALLED ON THE HEATER.
- 8) HEATERS AND PUMP MOTORS SHALL BE ON A TIME SWITCH.
- 9) HEATED POOLS AND SPAS SHALL BE PROVIDED WITH A VAPOR RETARDENT COVER.

PLANS MUST BE ON SITE FOR ALL INSPECTIONS
