The voter-approval rate is the highest tax rate that CITY OF DANBURY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that CITY OF DANBURY is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 7, 2023 AT 6:30PM AT the Danbury City Hall, 6102 5th Street, Danbury, Texas 77534.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, CITY OF DANBURY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of CITY OF DANBURY at their offices or by attending the public meeting mentioned above.
